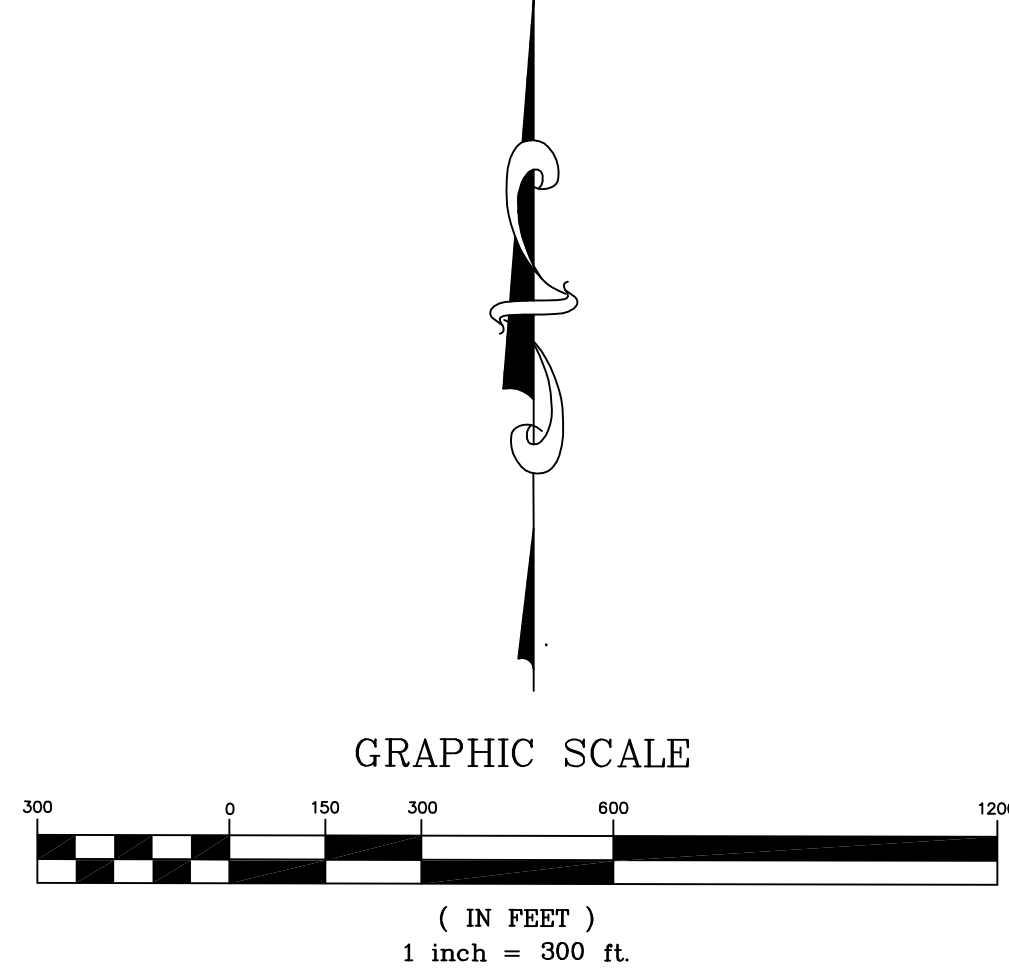


LEGEND:

PLACERITA CANYON CORPORATION – GATE SERVICE BOUNDARY MAP DEFINITIONS:

1. THE CORPORATION'S GATE SERVICE BOUNDARY IS GENERALLY DEFINED AS CONFINED TO PLACERITA CANYON, INCLUDING PLACERITA CANYON ROAD AS FURTHER SPECIFIED AND DEFINED IN THE JUDGMENT ENTERED IN LOS ANGELES SUPERIOR COURT CASE NO. PC009594 (HOMEOWNERS AGAINST LIABILITY AND TRAFFIC V. CITY OF SANTA CLARITA) WITH GATE CARD ACCESS GRANTED AT THE SOLE DISCRETION OF THE BOARD OF DIRECTORS OF PLACERITA CANYON CORPORATION.
2. SUCH GATE CARD ACCESS BOUNDARY IS FURTHER DEFINED BY THIS HIGHLIGHTED BOUNDARY MAP. ONLY RESIDENTS OR PROPERTY OWNERS AND/OR AREAS SITUATED WITHIN THE RED HIGHLIGHTED BOUNDARY CAN APPLY FOR GATE CARD ACCESS AND SUCH GATE CARD ACCESS IS SUBJECT TO AND SOLELY GRANTED AT THE DISCRETION OF THE BOARD OF DIRECTORS OF PLACERITA CANYON CORPORATION.
3. GATE CARD ACCESS BOUNDARIES ARE WITHIN, ARE SMALLER THAN, ARE NOT DEFINED BY AND NOT GOVERNED BY THE PLACERITA CANYON SPECIAL STANDARDS DISTRICT OR ANY OTHER DISTRICT ENACTED WITHIN NEWHALL, BY THE CITY OF SANTA CLARITA, CALIFORNIA.
